This state-of-the art justice centre in Leamington Spa is being built by Galliford Try under a design and build contract to serve South Warwickshire.

The new five-storey 6,500 sq m building is being built on the site of the old magistrates' court on Newbold Terrace in Leamington Spa. This project, which is due to complete in July 2010, is set to be the model for all other new build justice centres in the UK.
